The "Granfondo Edita Pucinskaite for Emergency" is a non-competitive cycling event dedicated to racing bikes (Given the non-competitive nature, the use of pedal-assisted racing bicycles of a type appropriate to the altitude difficulty of the route is also allowed but not considered for the final ranking

The race is of the amateur cycle type and passes through characteristic streets and villages of the Pistoiese Mountains on asphalted roads (no dirt tracks are present) with the aim of enhancing the landscape and local food and wine but above all to raise charitable funds for of the non-governmental association "Emergency"; in particular, for 2022 a part of the proceeds will be dedicated to the Italy Project.

The event received the approval of CONI, Tuscany Region administration, the Municipality of Pistoia, the Municipality of San Marcello-Piteglio, the Municipality of Abetone-Cutigliano, the Municipality of Marliana.

ART. 1 – WHEN & WHERE

The race will take place on SUNDAY 19 JUNE 2022 in Pistoia, Italy

ART. 2 – ROUTES & START

The "Granfondo Edita Pucinslaite for Emergency" includes 3 different routes:

- **GRANFONDO "ABETONE"** 132 km,
- **MEDIO-FONDO "SPIGNANA"** 87 km,
- **FONDO "GERMINAIA"** 62 km,

For all the 3 routes it is mandatory the medical certificate valid for competitive cycling.

Each participant could choose the path that best suits , and the choice must be indicated at the time of registration. It is however possible to change the type of route up to the moment of departure without any penalty between routes.

The above is necessary both for logistical reasons and for the verification of the necessary medical certificate and may be limited or conditioned by the organization for technical and / or safety reasons.

In particular, there are limitations of liability for underage or over 70 athletes on the date of the event, see paragraph 4.

Minors aged 16 to 18, in addition to presenting a medical certificate and membership, can participate only if authorized by their parents or by those who exercise parental authority, the authorization form is available on the website at the regulation page.

The routes will be marked with arrows and specific signs. It is possible to download, altitudes plan and GPS tracks of the routes from the website www.gfeditapucinskaite.com on the routes page.



The departure will take place in the "French" style from 07.15 to 08.10 from Piazza del Duomo, Pistoia. After this time, the check-in departure service will no longer be guaranteed.

ART. 3 – UCI Membership

The "Granfondo Edita Pucinskaite per Emergency" is open to all those who have reached the age of 16 of both sexes.

For 2022, in order to respond promptly to the Italian legislation, it is necessary that all cyclists are registered with Bodies recognized by CONI or for the not Italian people recognized by UCI .

In case the participant doesn't have the UCI ID, he/she can ask for a daily assurance . the price is 10 additional to the std. quote

The Organization may at any time and at its sole discretion decide whether or not to accept the registration or to exclude a participant from the event if it could damage the image of the same.

ART. 4 – REGISTRATION AND PRICE

Registrations open to everyone from 15/01/2022 at 09:00 in the manner described below:

- STANDARD registration open to all for € 25.00 until the 1500 numbers available

Promotional fee of 1 free for every 10 participants: registration via appropriate forms to be downloaded from the registration page to be sent by email to avisbikeptasd@gmail.com

The registration fee, includes:

- The RACE PACKAGE with gifts and souvenirs of the event;
- The RACE NUMBER to attach to the bicycle;
- REFRESHMENT according to the length of the routes;
- The PASTA PARTY at the end of the event; *
- SHOWERS upon arrival. *

* Showers and Pasta Parties will be available in compliance with the ANTI-COVID19 ministerial rules in force on the date of the event. The organization will take care of appropriate communication in advance through the website or social network channels to the participants regarding the possibility of using these services.

Online registrations on the ENDU platform will be closed on Friday 17 June 2022 at 24.00

It will be possible to register in the logistics area but at the moment it is not recommended due to the potential containment situation related to the COVID-19 emergency. In case, please contact avisbikeptasd@gmail.com by mail for the preparation of the registration data.

“Last-minute” registrations will be managed by 07.00 on Sunday 19/06 upon payment in cash at a single cost of 35 euros per participant (on top 10 € per day assurance in the case of non-UCI members).

The participation of under-18 and over 70s, it is limited to the 87km “Spignana” route. The organization declines any responsibility in case the athlete continues on the 132 km Abetone path.

The organization requires each athlete to send a mobile phone number and the e-mail for service communications or for emergency situations. The data will be processed in compliance with current privacy legislation

ART. 5 – Italian “Road Code” respect

The “Granfondo Edita Pucinskaite for Emergency” is a FREE EXCURSION cycling event on paved roads; the whole route will always be open to traffic and therefore compliance with the “Road Code” is mandatory for all participants. It is also mandatory to have a kit for repairing faults and punctures and in particular the use of a helmet is mandatory (under penalty of disqualification). In the “Crono” sections the roads will be closed to traffic, with the passage of a technical Car and with the guarantee of specific personnel at the junction points with other ordinary roads. However, the maximum attention of the participants is recommended. The section will be closed to traffic for a period of 15 minutes from the passage of the first runner as per the std ordinance of the Prefecture. When the car with the panel “End of the cycling race” passes, the road will be open to ordinary traffic, therefore the highway code is valid.

ART. 6 – REGISTRATION VALIDITY

Registration can be considered valid only after completing the electronic registration procedure with consequent electronic crediting of the amount in favor of the organizer.

The organization of the event declines all responsibility for potential injuries or non-compliant health conditions of the athlete not covered by insurance from the sporting institution to which they belong.

The organization of "Granfondo Edita Pucinskaite for Emergency" may, at any time and at its sole discretion, without the obligation to provide further reasons, decide whether or not to accept anyone's registration.

ART. 7 – REPLACEMENT OR WAIVE

It is possible to request the replacement of a participant within 21 days from the date of the Event only if the applicant is up to date with the registration, having sent the forms by that date and the registration fee. A contribution of € 5.00 will be required for this change operation.

If a member does not participate in the event and has not sent a replacement request within the deadline set out in the previous paragraph, the participation fee will not be refunded and the race package will not be delivered

However, within 21 days prior to the date of the event, the member will be entitled to communicate the renouncement of participation only due to unexpected impossibility related to an injury documented by clinical reports by sending an e-mail to the following address avisbikeptasd@gmail.com. The medical documentation will be treated in compliance with the current privacy legislation. After verifying the reasons for the cancellation and the related reports, the Organization will recognize the validity of the registration for the same event organized in the following year, without prejudice to the administration fee of € 5.00 to be paid during the registration period for the event of the following year. This registration, valid only for the following year, will however be nominal and not transferable to third parties. In case of further non-participation, the fee will therefore be considered lost.

It is therefore understood that in no case will the participation fee be refunded and in no case will the race package be delivered or sent.

ART. 8 - RACE NUMBERS WITH IDENTITY DOCUMENT

In Pistoia, in the Logistics area, that will be indicated on the event website, the RACE NUMBERS will be distributed before the event according to the following times:

- Saturday 18 Giugno from 10.30 to 12:30 and from 15:00 to 19:30
- Sunday 19 Giugno from 05:40 to 07:00

To collect the TECHNICAL PACKAGE and the RACE PACKAGE it will be necessary to present:

- The printing of the registration generated by the platform (or visualization in digital form on a smartphone)



- Competitive sports card or medical certificate pursuant to art. 3 of this regulation; Documento d'identità valido.

- According to the regulations in force at the date of the event: COVID-19 self-certification see Download link or valid GreenPass

To collect the TECHNICAL PACKAGE and the RACE PACKAGE it will be possible to "delegate" a friend or trusted person by delivering:

The printout of the registration generated by the platform and DELEGATION duly completed and signed in original, the model can be downloaded on the regulation page. In addition, you will need:

- Copy of the identity document of the delegator;
- Copy of the competitive sports card or the original of the medical certificate pursuant to art. 3 of this regulation;
- Valid identity document of the delegate.

The above remains valid only if the personal GreenPass is NOT mandatory on the date of the event. Otherwise it will NOT be possible to withdraw by proxy.

ART. 9 - CLOSING OF THE ROUTES, ASSISTANCE

The maximum time to complete all the routes is set for 2.30 pm

After this time, the Pasta Party service and check-out at the finish line will not be guaranteed for proof of arrival

At the location "Ponte di Lizzano", starting from 11:00, will be mandatory to turn on the 87 km Medio-Fondo route (Spignana)

There is no health care, except for a S.O.S. emergency doctor 112 or by calling the emergency number +39 375 7163975. Mechanical assistance is not provided outside the points provided by the organization.

ART. 10 – REFRESHMENT & CHECK POINT

Along the routes there are refreshment and supply points (marked with R on the gpx maps) equipped with drinks, sweet and savory food. Please note that both the RESTAURANTS and DRINKS points will ALWAYS be FREE by showing the bracelet included in the race pack. Apertura/Chiusura ristori, controlli e punti di assistenza tecnica:

- LE PIASTRE – 19,4 km – Refreshment opening 07:30, closing 9:30.
- SPIGNANA – 41,1 km – Refreshment & technical assistance – opening 08:15, closing 11:00;
- ABETONE - km 61,5 (percorso Lungo) – Refreshment & technical assistance – opening 10:00, closing 13:00;



- CASA DI MONTE – Km 60,8 (route Spignana) km 102,3 (route Abetone) – Refreshment – opening 11.00 chiusura ore 13:30;
- Circolo ARCI Santomato – Km38,5 (route Germinia) closure 12.00
- PISTOIA Logistic Area – PASTA PARTY – opening 11:30, closing 15:00;

There are 2 timed sections that will be managed through MYSDAM personal CHIP.

Both purchase and rental will be possible upon collection of the race envelope.

Crono 1 - Le Grazie : 8,2 km – 486 mt dsl

Start : Piestro km 7,2 – quota 180 mt

Finish : Villa di Cireglio km 15,4 – quota 666 mt

Crono 2 – Spignana : 2,2 km – 190 mt dsl

Start : Ponte km 38,8 – quota 562 mt

Finish : Spignana km 41,0 – quota 750 mt

Control points will also be provided along the various routes in order to certify the passage on the type of route (long / medium / short) for the report of the rankings as per ART. 11.

ART. 15 - CANCELLATION OR POSTPONEMENT OF THE EVENT

Cancellation - If, due to force majeure, the event does not take place, the amount paid at the time of registration will not be refunded, but only the participation fee will be considered valid in the event of a request to register for the next edition. The organization will also be entitled to a secretarial contribution of € 5.00 for postponing registration to the following year. The request for registration for the following year and the payment of the secretarial contribution must be made by the date indicated by the organization after the cancellation of the event.

Relocation - Furthermore, for reasons of force majeure or other serious reasons, which could jeopardize the preparation of the event, the Organization reserves the right to move the place and / or date of the event within the same calendar year. In this case, the fee paid for registration will be valid for the event on the rescheduled date, without increasing costs for the members. In this case, it is not possible to move the registration to the following year's edition.

ART. 16 - CHANGES

In the face of new environmental and / or health circumstances and / or in the event of changes to the regulatory framework, the Organization reserves the right to make consequent and reasonable changes to the regulation at any time. - They will make detours from the route that are not allowed; There are checkpoints along the official routes
- They will engage in abusive and offensive behavior towards the employees of the Organization;
- They will behave non-respectfully of the environment such as throwing waste outside the spaces set up at the refreshment points and controls.

We appeal to the civic sense of all participants so that the territories along the route remain clean.
